5	The above clause sounds as if the space has few systems already in place, but somewhere in the RFP you say it is a shell with minimum HVAC and lighting. Please clarify.	The building surrounding the space is fully modernized. The space to be addressed by this scope has minimal lighting and HVAC provided already within it.
6	Building system assessment as per clause 2.2.1.1 and Concept Design per clause 2.2.1.3 schedule looks to be very aggressive and concept design cant be done before building system assessment, we think. Please clarify.	Building System Assessment should be executed as pertinent to this scope.
7	Are CAD drawings available for this school?	PDF files only
8	Please clarify on the area of renovation. Page 3, Section 1.1 Project Overview states; "to create 3 classrooms and two small group/resource rooms, ultimately to create approximately 5,000 gross square feet of new spaces", whereas Page 4, Section 1.2 Project Background and Information about the School states; "The project will renovate roughly 6,200 square feet of unfinished interior space to create three classrooms and two small group/resource rooms".	Refer to Education Specifications and drawings attached as part of the RFP. The available space is slightly greater than the Ed Spec required square footage called for, but may not be 100% inclusive of connecting areas, etc.

9	Section 1.3 provides a budget of \$4,400,000 for the project. Please clarify is this the construction budget? Or, if FF&E and other costs are included.	This budget is inclusive of FF&E, as well as other soft costs included within the bid proposal. This is the total project budget.
10	Please clarify Attachment C The Offeror's Bid; Item A. Design Fee to contain Design Fee up to completing the Design Development (GMP) fee only	The Design fee should be inclusive of all design services included within the project scope for the awarded Design-Builder
11	Please clarify, Page 7, Section 1.6; third paragraph states "(ii) assist DCPS in relocating FF&E and other items, as necessary to complete the phased renovation. Whereas, Page 12 Section 2 Scope of Work states "provide design, selection, procurement and installation of all FF&E."	The space is currently storage for items which may need to be moved prior to construction. DGS and DCPS will work with the school to completely vacate the space, but in the case that items remain and must be relocated to another storage area within the school, the winning Design-Builder will be responsible.
12	Page 7 provides a scheduled date of award in January 2020 and the Concept submission on January 6, 2020. Please inform how many days we should consider for development of the Concept?	Up to 6 days. The concept design is expected to be largely based on design elements included in the proposal. Additionally, based on actual award date the Department reserves the right to adjust the milestone dates accordingly.
13	Which grades will be using the classrooms?	Per DCPS Education Specifications (Attachment A) Three (3) grades 2-5 classrooms, and one (1) resource room. These will not be used for early childhood education.
14	Please advise if the bid bond should be based on 5% of the total cost of General Conditions, since the construction cost is not known at this time.	5% of the amount of the price proposal.

15	There is a subcontracting plan attached to this RFP. Since we will not be able to develop realistic subcontracting plan until the final construction costs are established, how would you like us to proceed? In other words, did you want the subcontracting plan attached to this proposal or wait until an award has been made?	For Design-Build projects, the SBE subcontracting plan is not required to be submitted for preconstruction services. However the full SBE subcontracting plan (35% of the amount of the contract, including total design and construction cost) is required before entering into a Guaranteed Maximum Price (GMP) or contract/Letter Contract authorizing construction. Accordingly, the Offeror shall submit a subcontracting plan in the form of (Attachment I) indicating on the form that a full and complete SBE plan will be submitted before construction begins. 	LEED Gold is listed as a minimum requirement. For such a relatively small project, LEED Gold may be difficult to achieve. Is this certification an absolute?	
40	Is the Energy Star Certification required for the entire building?	Only for the portion addressed by this scope.

41	DOEE Stormwater Retention Credit are listed as a requirement. With a project of this size, stormwater may net be required.	The Department is not sure what the question is.
42	Are the RiverSmart Rooftop Registration forms required for this interior project?	If not applicable or qualifiable no per Section 1.2
43	There is reference to an "electronic project management" system to be provided by the Design-Builder. There is also a requirement for the Design-Builder to use Prolog for some of the same functions. 46	There does not appear to be specific requirements for BIM other than a mention in Section 2.9.3. If BIM is required, indicate to what extent should the BIM include? Entire building? Or, just the area included in the scope of this project?	There is no BIM requirement for this project.
47	Please explain this requirement further as it appears that DGS will be providing a IT/AV/Security consultant and the Design-Builder will not need to provide those design services: "It is the Department's desire to procure separately a network engineering design that will fully integrate the network infrastructure and IT equipment, along with all Building Automation System ("BAS") technology. This network engineering design and technology will need to be incorporated and coordinated with the awarded Design-Builder's design."	DCPS Security will advise as to required features. OCTO will provide details to properly accommodate classrooms. It is the expectation that the new classroom spaces be integrated fully into the existing building systems.
