No.	Questions	Answers
1	Section E.4.1.4 Project Management Plan states "The Project Management Plan should contain the information requested in Section D.3.3 of the RFQ" and D.3.3 states "The oral presentation will be made by the Offeror's personnel who will be assigned the key jobs for this project. Each Offeror will be limited to 7 persons. The job functions of the persons attending the presentation will be considered to be an indication of the Offeror's assessment of the key areas of responsibility that are deemed essential to the successful completion of the project", how is this applicable? Did you mean D.4.3?	See item No. 2 of this addendum.
2	Should the completed Past Performance Evaluation, Attachment A, forms be included in the final proposal?	Refer to Section E.4.1.3 of the RFQ. It is up to the Offeror to additionally include filled Attachment A to their final submission.
3	It states on page 29 that "Each Offer should provide a summary of no more than three pages of the information contained in Section E.4.1.2". Section E.4.1.2 askes for a large amount of information, including all proposed personnel resumes. Are these in addition to the three allowed pages?	Refer to Section E.4.1.3 of the RFQ. It is up to the Offeror to additionally include filled attachment A to their final submission.
4	Section E.4.1.5 Capacity (ii) states that you need to provide our firms Dun & Bradstreet report for calendar year 2018, what if we do not have a report?	The RFQ is requesting for a summary of that information. The information can be provided as a list or chart. Resumes should indicate the individual's experience on the five (5) relevant projects and identify the role of the individual in each past project noted on the resume, identify how long the individual has worked in the construction industry and should indicate the number of years of experience in his or her current role and the prior roles.
5	Can we go after one or two of the trades or do we have to bid them all as a whole?	For clarity, this is not an RFQ for individual trades contractors. DGS is seeking entities to complete construction projects on a design-build or design-assist basis. The Contractor shall be capable of managing projects involving a single trade or multiple trades.
6	Will the sign in sheet from the project information meeting be made available?	Refer to Item No.1 of this Addendum.
