3	At EC No. 5, please clarify if any of the existing mechanical equipment is existing to remain.	The only penetrations / equipment on the roof are roof vents and the antennae which are to remain.
4	At EC No. 8, please confirm the HVAC equipment that is serviced by the gas line can be taken out of commission while work is complete.	It is the intent of the design for the contractor to use a low profile, non-penetrating conduit support. Contractor is to verify that the new roof system and new supports will work with the existing conditions. Addendum 1 provides a product that will work with the new system and roof thickness. The HVAC units can be taken out of commission for up to 2 weeks while work is being performed if necessary.
