DETERMINATION AND FINDINGS FOR SOLE SOURCE EXTENSION OF A COMPETITIVELY AWARDED CONTRACT BEYOND FIVE YEARS

FINDINGS

1. AUTHORIZATION:

D.C. Official Code §2-354.04, 27 DCMR Chapter 13 1304.1, 1700, 1701, 2005.2(b)

2. MINIMUM NEED:

The Department of General Services ("DGS" or the "Department"), on behalf of Facilities Management Division ("FMD"), has an immediate need for the current Contractor, The Donahoe Companies, Inc ("Donahoe" or "Contractor") to continue providing Consolidated Maintenance Services at Unified Communications Center & Public Safety Communications Center ("UCC & PSCC") for an additional period of up-to three (3)-months and twenty eight (28)-days, through 30-April-2021 and until the Department awards of a new contract. This additional three (3)-month and twenty-eight (28)-day extension will assure the avoidance of any disruption to critical facility operation services during the impending period while a new solicitation for these services is procured following significant scope changes.

3. ESTIMATED FAIR AND REASONABLE PRICE:

The estimated fair and reasonable price for the three (3)-month and twenty-eight (28)-day sole source contract extension is Eight Hundred Fifty-Four Thousand, Nine Hundred and Four Dollars and eighty-one cents (\$854,904.81) for Basic Services, and One Hundred Thousand Dollars and zero cents (\$100,000.00) for cost reimbursement, for a Total Not-to-Exceed Contract Ceiling of Nine Hundred Fifty-Four Thousand, Nine Hundred and Four Dollars and eighty-one cents (\$954,904.81).

4. FACTS WHICH JUSTIFY A SOLE SOURCE EXTENSION OF CONTRACT:

It is the mission of DGS to provide first rate maintenance at District government facilities and to ensure a safe environment for the citizens, students, faculty, employees and visitors of the District of Columbia. The purpose of this sole source contract extension is to prevent an imminent threat to health, welfare, safety and serious disruption in agency operations at the Unified Communications Center & Public Safety Communications Center.

- 1. On January 4, 2016, the Contractor, The Donahoe Companies, Inc ("Donahoe"), was awarded the contract to provide consolidated maintenance services at Unified Communications Center & Public Safety Communications Center ("UCC & PSCC") for a twelve (12)-monthly base year period and four additional, one (1) year option periods.
- 2. The Department has determined that it is in the best interest of the District to extend the current contract with Donahoe from January 4, 2021 through April 30, 2020, a total of three (3)-months and twenty-eight (28)-days where Donahoe will continue providing consolidated maintenance services at UCC & PSCC as defined under the original contractual agreement.
- 3. The Department is in the process of conducting significant changes and updates to the current scope of work and intends to issue a new solicitation within the next 45-days.
- 4. The incumbent is currently providing consolidated maintenance services at Unified Communications Center & Public Safety Communications Center and the continuity of these services is vital to the District.
- 5. The continuation of services being provide under the current contract with the incumbent is the most advantageous method to assure continuity of services delivery. This plan includes the continuation of service against the current contract DCAM-16-NC-0020 with no changes in monthly costs for basic services and hourly rates for supplemental reimbursable services.
- 6. The Donahoe Companies Inc, the current Contractor, is providing satisfactory services and is uniquely positioned to ensure continuity of services.
