FINDINGS

1. AUTHORITY:

D.C. Official Code §2-354.04 and Title 27 DCMR Section 4718.1

2. MINIMUM NEED:

The Department of General Services (DGS) on behalf of the Department of Youth Rehabilitation Services (DYRS) has an immediate need to complete the construction activities required to permit DYRS to comply with Section 16-2313 of the Comprehensive Youth Justice Amendment Act of 2016 (CYJAA) as amended which states "All persons under 18 years of age who are in the custody of the Department of Corrections shall be transferred to the custody of the Department of Youth Rehabilitation Services before October 1, 2018."

3. ESTIMATED FAIR AND REASONABLE PRICE:

The estimated fair and reasonable price to provide the required services is \$760,000.

4. FACTS WHICH JUSTIFY A SOLE SOURCE PROCUREMENT:

In July of 1986, the District of Columbia entered into a consent decree known as the Jerry M Consent Decree. Jerry M. is the consent decree overseeing the Department of Youth Rehabilitative Services (DYRS).

Of the five remaining Work Plan Exit Criteria, the Court Monitor/Plaintiffs have found DYRS in compliance for the Staffing and Supervision Work Plan Goal and agreed to vacate this Work Plan Requirement (i.e., remove from Court supervision), on the condition that the Title XVI youth transfer occurs before October 1, 2018 as required, and that DYRS maintain the required staffing and supervision for a period of ninety days thereafter.

In order to accommodate the transfer of youth DYRS must successfully achieve the minimum need. Alternative Renewable Solutions, Inc. (ARS), as the current contractor on site, is most equipped to meet the new deadline. Time will be saved by as a result of ARS's intimate knowledge of the facilities and work to be performed. Previous lessons learned will become time saving benefits.

Construction delays that push back achievement of the appropriate transfer of Title XVI youth from DOC to DYRS New Beginnings by October 1, 2018 will severely impact the District's ability to exit this long-standing consent decree. If we do not meet the October 1, 2018 transfer deadline, as required by the CYJAA, we believe the Court Monitor and the plaintiffs will urge the Court to keep this part of the consent decree under Court supervision beyond 2018, resulting in a delay in DYRS exit of the Staffing and Supervision Work Plan Goal by at least one year.
