### Questions about the Solicitation

#### *Add/Incorporate:*

Each Offeror should carefully examine this RFQ and any and all amendments, addenda, or other revisions, and thoroughly familiarize itself with all requirements prior to proffering a SOQ Submission. Should an Offeror find discrepancies or ambiguities in, or missives from, the RFQ and amendments, addenda, or revisions, or otherwise desire an explanation or interpretation of the RFQ, any amendments, addenda, or revisions, it must submit a request for interpretation or correction *in writing no later than Monday March 7, 2022*. Any information given to an Offeror concerning the RFQ shall be furnished promptly to all other Offerors as an amendment or addendum to this RFQ if in the sole discretion of the Department that information is necessary in proffering SOQ Submissions or if the lack of it would be prejudicial to any other prospective Offerors. Oral explanations or instructions given before the award of the contract shall not be binding.

All questions pertaining to the solicitation shall be submitted electronically via the Vendor Bid/Proposal Submission Portal no later than close of business on *Monday March 7, 2022*.
