## **FINDINGS**

### **1. AUTHORIZATION:**

### 2. MINIMUM NEED:

The Department of General Services (DGS) has an immediate need for American Construct, LLC to provide plumbing repair for water main break at DYRS New Beginnings, Laurel Campus

### 3. ESTIMATED FAIR AND REASONABLE PRICE:

The estimated fair and reasonable price for Services is \$27,336.00.

### 4. FACTS WHICH JUSTIFY AN EMERGENCY PROCUREMENT:

Official Code §2-354.05 and 27 DCMR 4719, the purpose of this emergency contract is to prevent an unsafe workspace that would cause a threat to public welfare and property. In addition, the services are required immediately, on an emergency basis to prevent a disruption of the daily operations at the Department of Youth Rehabilitation Service at New Beginnings, Laurel Campus. It is the mission and the responsibility of the Department of General Services to provide safe and healthy facilities to all District owned and or operated facilities throughout the District as ordered under (D.C. Code § 10-551.01(b) (4), The Department of General Services Establishment Act of 2011.).
