# **FINDINGS**

### 1. AUTHORIZATION:

D.C. Code Section 2-354.04 and DCMR 47, Section 4718

### 2. MINIMUM NEED:

The Department of General Services (DGS) Office of the Director, Grant Management and Financial Operations has an immediate and on-going need for strategic consulting management services in support of the Departments' financial activities related to grants, budget and COVID development programs through December 31, 2022.

### 3. ESTIMATED REASONABLE PRICE:

The Contract will have a not-to-exceed value up-to \$995,000.00 based on fixed hourly consulting fees as delineated in the below table.

### 4. FACTS WHICH JUSTIFY SOLE SOURCE PROCUREMENT:

Federal Management Systems, Inc. (FMS), a certified small business enterprise, has provided strategic management consulting services to DGS since April of 2017. The

contractor provides key consulting services, including strategic planning, program implementation assistance and ad-hock auxiliary support related to grant funding, program support and fiscal recovery fund processes and compliance.

FMS provides subject matter expertise in forecasting and benchmarking facilities' costs and expenditures across facility types and integration into applications used by DGS for budget execution and communication to customer agencies. FMS subject matter experts are providing consulting and technical support require to meet the demands of COVID invoices using Robotic Process Automation (RPA) and responding to Federal funding notices to address needs across HVAC, energy, workforce development, and exterior facility management. In addition, FMS assist with the analysis of other services managed by DGS, such as HVAC funding, Alterations Report, Budget Reports, and Delegated Parking Authority. FMS has specialized training on how to use DGS's various systems as it pertains to budget development. Also, FMS has specialized training on how to retrieve and maintain all materials for compliance and audits.

To this end, the Contractor's historical knowledge of the Departments' grant, fiscal recovery fund, budget development, invoice reconciliation, audit, compliance standards and robotic process automation, affords the Contractor unique experience and expertise, not immediately or readily available through other vendors. Furthermore, the unique experience will ensure the Department maintains continuity of the aforementioned processes and budget planning activities. Thus, Federal Management System is the only company with the experience, expertise, historical and programmatic knowledge coupled with the technology to complete the required services in the available timeframe.
