DETERMINATION AND FINDINGS FOR SOLE SOURCE PROCUREMENT

Caption: MPD 1st District Head Quarters – ADA Upgrades at MPD 1st District (MPD1D)

District Substation located at 500 E Street, SE, Washington DC, 20003.

Architecture Engineering (AE) and Construction Administration (CA) Services

Only.

Contractor: Studio Laan

FINDINGS

1. AUTHORIZATION:

D.C. Code Section 2-354.04 and DCMR 47, Section 4718.

2. MINIMUM NEED:

The Department of General Services (DGS) has an immediate need for time extension to complete AE Services and to begin CA services required at MPD 1st District Substation located at 500 E Street, SE, Washington DC, 20003.

ESTIMATED FAIR AND REASONABLE PRICE:

The estimated fair and reasonable price is up to \$10,568.50.

3. FACTS WHICH JUSTIFY A SOLE SOURCE PROCUREMENT:

Based on their need for ADA Upgrades, MPD 1st District Substation requested Architecture Engineering (AE), Construction Administration (CA) and General Contracting (GC) services to take place. Through a competitive procurement process that took place, DGS awarded a contract to Studio Laan Architects to complete the AE and oversee the CA portion. The GC portion was scheduled to be completed via a separate competitive

procurement process by a separate GC. The initial DGS PM who oversaw the AE portion this project is no longer employed with DGS. Immediately following him leaving DGS, the AE portion of the contract expired. After expiration of the AE portion of the contract, bids that were previously solicited for the GC portion of the project started to arrive based on the anticipated timeline at that time.

Due to the challenging nature of MPD 1st District projects, Studio Laan will utilize the original design and field staff members that are familiar with the current construction drawings as well as the constraints imposed by MPD 1st District. Studio Laan, having been involved since June 2019 for AE Services, is familiar with the site, staff, logistics and requirements of MPD staff.

In addition to being more costly for a new contractor to validate the AE services already completed, the project had reached the 90% point of completion. The remaining 10% is to be completed once the GC is selected. Further, DGS has successfully negotiated the reinstatement of the permit from DCRA with the submitted and approved forms and documents from Studio Laan. Once approved to restart, it is expected that the rest of the project which includes the remaining AE, CA and GC will be complete in approximately 5-6 months.

Based on the above, it is in the best interest of the District to allow Studio Laan, the original AE of record for the MPD ADA Upgrades Project at 1st District to review, complete comments for permits and submit specifications for completing construction. This will ensure construction that will comply with and complement standards, applicable safety codes, and operational needs of the MPD 1st District ADA Upgrades project.
