The estimated reasonable price is \$639,406.60 (Six Hundred Thirty-Nine Thousand, Four Hundred Six Dollars and Sixty Cent).

4. FACTS WHICH JUSTIFY AN SOLE SOURCE PROCUREMENT:

In accordance with the PPRA Sec. 413.8, the purchase of maintenance and support services of existing software and technology to the extent that the creator of the intellectual property is protected and is the only source of the maintenance and support of the existing software and technology; the Contract shall be exempt from competition requirements established by this act.
