## DETERMINATION AND FINDINGS FOR A SOLE SOURCE PROCUREMENT

## **FINDINGS**

## **1. AUTHORIZATION:**

D.C. Official Code §2-354.04, 27 DCMR 1304 and 27 DCMR 4718

### 2. MINIMUM NEED:

The Government of the District of Columbia, acting by and through its Department of General Services (the "Department" or "DGS"), has a continued need for ongoing use of EnergyCAP's advanced software license for BillCapture, annual maintenance, advanced database hosting, and training services. The Contractor shall provide services for the period beginning January 1, 2023 through September 30, 2023.

## 3. ESTIMATED FAIR AND REASONABLE PRICE:

The estimated fair and reasonable price for the contract is One Hundred Eighty-Nine Thousand Two Hundred Forty-Five Dollars and sixty-one cents (\$189,245.61) for the base period, from January 1, 2023 through September 30, 2023.

The estimated fair and reasonable price for Option Year 1-4 is as follows:

Option Year 1	\$259,897.28
Option Year 2	\$267,694.21
Option Year 3	\$289,109.75
Option Year 4	\$312,238.53

All services are priced based on firm, fixed monthly service rates which include wages, overhead, general, and administrative expenses, profit, insurance and all else as

reasonably inferred to ensure the Contractors timely and cost-effective delivery of services.

## 4. FACTS WHICH JUSTIFY A SOLE SOURCE PROCUREMENT:

In fiscal year 2017, DGS purchased a perpetual advanced software license from EnergyCAP to track and manage utility bills and energy and sustainability information. This included annual maintenance, an advanced software license for 4,100 meters, software updates, database hosting services, implementation services, and training services. Additionally, EnergyCAP Bill Capture service processes and continually audits roughly 60,000 annual utility transactions for DGS.

DGS requires ongoing use of EnergyCAP's software and services to track, audit, and manage utility bills and energy and sustainability information. This sole source is needed to maximize DGS' previous investment in the software and services that have been tailored to DGS' specific billing and payment processes.
