FINDINGS

1. AUTHORIZATION:

D.C. Code Section 2-354.04 and DCMR 27 Section 4718.

2. MINIMUM NEED:

The Department of General Services (the “Department” or “DGS”) has an immediate need to engage the services of WKM Solutions, LLC. (“Contractor”) for Swing Space for School Without Wall at Francis Stevens Education Campus at the Former Banneker Facility, located 2425 N Street NW, Washington, DC 20037. Work location is 800 Euclid St NW, Washington, DC 20001.

3. ESTIMATED FAIR AND REASONABLE PRICE:

The estimated fair and reasonable price to provide the work for Swing Space for School Without Wall at Francis Stevens Education Campus at the Former Banneker Facility is approximately **\$138,503.70**.

4. FACTS THAT JUSTIFY A SOLE SOURCE PROCUREMENT:

DGS as an agency of the District of Columbia government is responsible for constructing, sustaining, and maintaining all DC Public Schools (“DCPS”) facilities. This is to provide additional logo and premium time to complete the project by school opening. The scope is expanded for the existing PA system, updated hardware at exterior door locations for life safety detection, and additional hardware low voltage lines into classrooms.

WKM Solutions, LLC was engaged by the Department under Basic Ordering Agreement No. DCAM-17-CS-0033I to perform various construction activities for the Swing Space for School Without Wall at Francis Stevens Education Campus at the Former Banneker Facility, Project.

WKM Solutions, LLC. is a resident owned SBE and their knowledge and familiarity with DCPS schools will translate to a faster operative evaluation of the Swing Space for School Without Wall at Francis Stevens Education Campus at the Former Banneker Facility Project. In addition, WKM Solution, LLC. will be able to provide remediation recommendations that are in line with DGS expectations.

Based on the above, it is in the District's best interest to allow WKM Solution, LLC. to complete the Swing Space for School Without Wall at Francis Stevens Education Campus at the Former Banneker Facility, Project.
