FOR  
SOLE SOURCE EXTENSION OF A COMPETITIVELY AWARDED CONTRACT  
BEYOND FIVE YEARS**

**Agency:** Department of General Services

**Caption:** Consolidated Maintenance Services at John A. Wilson Building

**FINDINGS**

**1. AUTHORIZATION:**

D.C. Official Code §2-354.04, 27 DCMR Chapter 13 1304.1, 1700, 1701, 2005.2(b)

**2. MINIMUM NEED:**

The Department of General Services (“DGS” or the “Department”), on behalf of Facilities Management Division (“FMD”), has an immediate need for the current contractor, RWD Consulting, LLC (“RWD” or “Contractor”) to continue providing Consolidated Maintenance Services at the John A. Wilson Building (“Wilson Building”) for an additional 120-days until the Department anticipates award of a new contract. This additional 120-day extension will assure the avoidance of disruption of services during the preceding period while a new solicitation for these services is procured following major scope changes.

**3. ESTIMATED FAIR AND REASONABLE PRICE:**

The estimated fair and reasonable price for the 120-day sole source contract extension is Four Hundred Eighty Thousand Eight Hundred Ninety-Two Dollars and sixty-one cents (\$480,892.61) for Basic Services, and One Hundred Fifty Thousand Dollars and zero cents (\$150,000.00) for cost reimbursement, for a Total Not-to-Exceed amount of Six Hundred Thirty Thousand Eight Hundred Ninety-Two Dollars and sixty-one cents (\$630,892.61).

**4. FACTS WHICH JUSTIFY A SOLE SOURCE EXTENSION OF CONTRACT:**

It is the mission of DGS to provide first rate maintenance at District government facilities and to ensure a safe environment for the citizens, employees and visitors of the District of Columbia. The purpose of this sole source contract extension is to prevent an imminent threat to health, welfare, property and safety and serious disruption in agency operations to the Wilson Building

1. On August 25, 2014, the Contractor, RWD, was awarded the contract to provide consolidated maintenance services at the Wilson Building, which houses the municipal offices and chambers of the Mayor and the Council of the District of Columbia.
2. The Department has determined that it is in the best interest of the District to extend the current contract with RWD from August 25, 2019 through December 22, 2019, to continue providing consolidated maintenance services at the Wilson Building as defined under the original contractual agreement.
3. The Department is in the process of conducting major scope changes to the solicitation and it is the intent of the Department to issue a new solicitation within the next 30 days.
4. The incumbent that is currently providing consolidated maintenance services at Wilson Building is vital to the District and this service must be continued without interruption.
5. The incumbent is the most advantageous to the District to provide this service. This is a continuation of service against the current contract DCAM-14-NC-0099A with no changes in monthly costs for basic services and hourly rates for reimbursable services.
6. The current contractor is providing satisfactory services and is uniquely positioned to ensure continuity of services.
7. A sole source contract extension is the most advantageous method to minimize disruption to overall facility operations; it ensures a continuation of service while the District prepares and finalizes a solicitation for competition and awards a multi-year contract upon Council approval.
