FINDINGS

1. AUTHORIZATION:

D.C. Code Section 2-354.04 and DCMR 27 Section 4718.

2. MINIMUM NEED:

The Department of General Services (the "Department" or "DGS") has an immediate need to engage the services of WKM Solutions, LLC. ("Contractor") for Capitol Hill Montessori at Logan ("CHML") Playground & Roof Upgrades, located at 215 G Street NE, Washington, DC 20002.

3. ESTIMATED FAIR AND REASONABLE PRICE:

The estimated fair and reasonable price to provide the work for CHML Playground & Roof Upgrades is approximately **\$631,398.95**.

4. FACTS THAT JUSTIFY A SOLE SOURCE PROCUREMENT:

DGS as an agency of the District of Columbia government is responsible for constructing, sustaining, and maintaining all District of Columbia Public Schools ("DCPS") facilities. This contract is to demolish existing 5-12 playground equipment and PIP surfacing, furnish and install new 5-12 playground equipment and PIP surfacing, perform inspections and certifications as required, replace the existing roof over the library space with a new low slope roof, and replace any site furnishings disturbed as part of material lay-down and site logistics.

The following must be completed to mitigate the impact on the project schedule:

- a) Demolish existing 5-12 playground equipment and PIP surfacing. (2-5 to remain in place);
- b) Furnish and install new 5-12 playground equipment and PIP surfacing;
- c) Construct the new playground in the same location as the existing playground;
- d) Perform playground inspections and certifications as required;

- e) Replace the existing roof over the library space with a new low-slope roof; and
- f) Replace any site furnishings disturbed as part of material lay-down and site logistics.

The above-referenced works must be completed without delay by October 16, 2023.

WKM Solutions, LLC. is an SBE and their knowledge and familiarity with DCPS schools will translate to a faster operative evaluation of the CHML Playground & Roof Upgrades Project. In addition, WKM Solutions, LLC. will be able to provide remediation recommendations that are in line with DGS expectations.

Based on the above, it is in the District's best interest to allow WKM Solutions, LLC. to complete the CHML Playground & Roof Upgrades Project.
