# DETERMINATION AND FINDINGS FOR EMERGENCY PROCUREMENT

**Agency:** Department of General Services (the "Department" or "DGS")

Contract: DCAM-23-NC-EM-0041

**Caption:** Emergency Consolidated Maintenance Services for the Banneker High School

**Contractor**: Spectrum Management, LLC ("Spectrum")

# **FINDINGS**

### 1. AUTHORIZATION:

Chapter 47 of title 27 of the DCMR Section 4719 and PPRA Sec. 405 (d); *Emergency Procurements*.

### 2. MINIMUM NEED:

The Department of General Services (DGS) has an immediate need for Spectrum Management, LLC to provide Emergency Consolidated Maintenance Services including operations, maintenance and repair services for Banneker High School located at 925 Rhode Island Avenue NW, Washington, D.C. 20001.

## 3. ESTIMATED FAIR AND REASONABLE PRICE:

The estimated fair and reasonable price is a total not-to-exceed amount of \$160,398.48 for basic services, plus a not-to-exceed amount of \$150,000.00 for cost reimbursement for a total not-to-exceed amount of \$310,398.48.

### 4. FACTS WHICH JUSTIFY AN EMERGENCY PROCUREMENT:

In accordance with the D.C. Official Code §2-354.05 and 27 DCMR 4719, the purpose of this emergency contract is to prevent an unsafe environment with the risk to bodily harm. In addition, the services are required immediately, on an emergency basis to prevent a disruption of the daily operations at Banneker High School. It is the mission and the responsibility of the Department of General Services to provide safe and healthy facilities to all District owned and or operated buildings throughout the District as ordered under (D.C. Code § 10-551.01(b) (4), The Department of General Services Establishment Act of 2011.).

- 1. The Department has determined that it is in the best interest of the District to continue services with the incumbent, SPECTRUM, under a temporary emergency contract, and SPECTRUM is the only vendor who can meet the District's minimum need without a disruption of services at this time.
- 2. SPECTRUM, based on relevant past performance, capacity and references has the relevant technical experience, is uniquely positioned to ensure continuity of services with no disruption to the daily operational needs of Banneker High School.
- 3. The estimated cost to the District for this temporary emergency period is fair and reasonable based on DGS' historical data on similar services.
- 4. An emergency procurement is the most advantageous method to minimize disruption to overall facility operations; it ensures a continuation of service while the Department issues a Request for Proposal and goes through the competitive solicitation process and award for a base period and up to four one-year option periods and upon Council approval, if applicable.
