FINDINGS

1. **AUTHORIZATION:**

Chapter 47 of title 27 of the DCMR Section 4719 and PPRA Sec. 405 (d); Emergency Procurements.

2. **MINIMUM NEED:**

The Department of General Services (DGS) has an immediate need for U Street Parking, Inc. Inc. to provide Emergency Parking Lot Management Services at 441 4th Street NW, 490 First Street NW and 2000 14th Street NW Washington, DC in accordance with Chapter 47 of title 27 of the DCMR Section 4719 and PPRA Sec. 405 (d); Emergency Procurements.

3. ESTIMATED FAIR AND REASONABLE PRICE:

The estimated fair and reasonable price is up to \$148,587.32

FACTS WHICH JUSTIFY AN EMERGENCY PROCUREMENT: 4.

In accordance with the D.C. Official Code §2-354.05, 27 DCMR 4719 and Title 21 DCMR, Chapter 20, the purpose of this emergency procurement is to prevent an imminent threat to public health, welfare and property; also, to prevent a dangerous environment for residents, employees and visitors of 441 4th Street NW, 490 First Street NW and 2000 14th Street NW Washington, DC. It is the mission and the responsibility of the Department of General Services to provide Parking Lot Management Services for facilities located at owned and operated by the District government; these responsibilities include providing Parking Lot Management Services located 441 4th Street NW, 490 First Street NW and 2000 14th Street NW Washington, DC. (D.C. Code § 10-551.01(b) (4), the Department of General Services Establishment Act of 2011.)

An Emergency Contract with U Street Parking, Inc. is needed to provide Parking Lot Management Services at to prevent life threatening situation or property damage. A new contract cannot be competitively bid and awarded in time to have a contractor in place to provide Parking Lot Management Services needed.

The Contractor referenced above is the only vendor who can meet the District's minimum need for Parking Lot Management Services at this time and the estimated cost to the District is fair and reasonable based on DGS' historical data on similar services. Moreover a competitive procurement process is not practicable under these circumstances and a new contract could not be competitively bid and awarded in time to have a service contractor in place to provide the required services. As previously stated failure to provide Parking Lot Management Services may result in creating life threatening or property damage for employees and visitors at 441 4th Street NW, 490 First Street NW and 2000 14th Street NW of the District.
