# **FINDINGS**

#### **1. AUTHORIZATION:**

Chapter 47 of title 27 of the DCMR Section 1702 and PPRA Sec. 405 (d); *Emergency Procurements*.

#### 2. MINIMUM NEED:

The Department of General Services (DGS) has an immediate need for RSC Electrical and Mechanical to provide comprehensive HVAC Technician Services for various District owned and operated facilities to ensure effective performance of all HVAC for a period of no more than 120-days in accordance with Chapter 47 of title 27 of the DCMR Section 1702 and PPRA Sec. 405 (d); Emergency Procurements.

#### 3. ESTIMATED FAIR AND REASONABLE PRICE:

The estimated fair and reasonable price for HVAC Technician Services will be provided on a Time and Materials basis with an aggregate amount Not-to-Exceed **<u>\$200,000</u>**.

#### 4. FACTS WHICH JUSTIFY AN EMERGENCY PROCUREMENT:

In accordance with the D.C. Official Code §2-354.05 and 27 DCMR Section 1702 and PPRA Sec. 405 (d), the purpose of this emergency contract is to prevent the unsafe conditions that could cause a threat to public health, welfare and property, and to prevent a disruption of the daily operations and critical care services provided by the Districts. It is the mission and the responsibility of the Department of General Services to provide building services for facilities owned and occupied by the District government including but not limited to HVAC maintenance and repair services, comprehensive janitorial, operations, maintenance and repair and trash collection, hauling and disposal services of various District owned and or operated facilities such as municipal buildings, schools,

> recreation centers, homeless shelters and transitional living facilities. (D.C. Code § 10-551.01(b) (4), "the Department of General Services Establishment Act of 2011")

> This Emergency Contract allows the District time to evaluate and award Solicitation DCAM-20-NC-RFP-0013 which will provide On-Call Facility Maintenance and Repair Services for Group A-HVAC Technician Services. As previously stated, failure to continue with services or any disruption of the daily operations would quickly create unsanitary, unhealthy and potentially life-threatening conditions for District government employees and the public. During this 120-day contract term the Contractor will perform the following:

- 1. Preventive Maintenance on cooling equipment for Summer readiness
- 2. Switchover of HVAC equipment from heating to cooling.
- 3. HVAC critical equipment repairs made after heating to cooling switchover.
- 4. Chemical water treatment repairs
