**DETERMINATION AND FINDINGS

SOLE SOURCE PROCUREMENT**

Purchasing Agency: Department of General Services
Caption: Commissioning Services
Proposed Contractor: A2 Services

FINDINGS

1. AUTHORIZATION:

D.C. Code Section 2-354.04 and DCMR 47, Section 4718.

2. MINIMUM NEED:

The District of Columbia, Department of General Services (“DGS or the “Department”) has an immediate need for **A2 Services** (“The Contractor”) to provide Commissioning Services to various Districts’ properties.

3. ESTIMATED FAIR AND REASONABLE PRICE:

The estimated fair and reasonable price for the commissioning services is Three Hundred Fifty Thousand Dollars and Zero Cents (**\$350,000.00**).

4. FACTS WHICH JUSTIFY A SOLE SOURCE PROCUREMENT:

The Department requires the Contractor to provide commissioning and mission critical support services to a) prevent serious disruption in agency operations, b) ensure active construction projects are delivered on schedule, c) ensure higher level of quality delivery, and d) ensure safe working conditions are maintained during construction and more importantly post-construction.

Construction work and permitting for District properties cannot proceed without certifications and the Contractor’s required services are provided at DGS and District of Columbia Public Schools (“DCPS”) project sites where the work involves renovations of

older and deteriorating structures and building and commissioning services are an essential part of the scope. Such commissioning work is an integral part of different types of construction, including demolition and renovations work.

The objective for DGS is to achieve Silver or higher rating from the US Green Building Council (USGBC) for LEED new construction or LEED Schools. The Contractor is required due to its knowledge in providing adequate Fundamental and Enhanced Commissioning for Leadership in Energy and Environmental Design Certification Services for the District in the past five years.

Therefore, the Contractor's services are needed to ensure the District is in compliance with the USGBC's rules and regulations for various construction projects and to ensure that the projects are delivered timely.
