





#### PROJECT OVERVIEW ADJUSTED (suggested on 6/13 meeting)




Adjustments suggested:

- 1. Fitness Center:
- Lack of Fitness-oriented spaces in the neighborhood,
- Consider the expansion of the Fitness Center to serve a higher number of patrons.

#### 2. Tech Lounge:

 Avoid duplication of publicly accessible amenities, such as the tech lounges, which are available in the area at different locations such as libraries, community organizations, etc. Use the space allocated for Tech Lounge to expand the Fitness Center.


