Protective Services Division (PSD) Security Survey 300 & 301 Van Buren Street, NW Date: August 8, 2019



#### Summary

During the past year, MPD crime statistics report that robbery without the use of a gun has increased in the areas of 300 and 301 Van Buren Street, NW. The current security posture of areas surrounding the Tacoma Recreation Center and the Community and Aquatic Center is poor, lacking fencing, security cameras, and lighting.

# Site Information of Tacoma Recreation Center

Tacoma Recreation Center located at 301 Van Buren Street, NW, has been having altercations on their basketball court during the past year. See MPD crime statistics below.

# **Tacoma Recreation Center**

### **Findings with Recommendations**

Closed Circuit Television (CCTV) There are no cameras on the exterior of the recreation facility.

• <u>Recommendation</u>: Cameras need to be placed on 14-foot poles, along the walkway, at the real of the recreation facility, and on the flood lights around the basketball court. The cameras should have vandal resistant domes around them.

## Lighting

• <u>Recommendation</u>

Lighting should be added along the walkway located at the rear of the recreational center, and around the basketball court. The area lacks sufficient lighting, and more lighting will provide additional safety for recreation centers visitors. It is recommended that the light poles should be at a height of 14 feet, and be protected by tough polycarbonate. The lights should be LED, which gives extra illumination and promotes a sense of security.

#### Site Information on Tacoma Community and Aquatic Center

The Tacoma Community and Aquatic Center located at 300 Van Buren Street, NW, has been having altercations on their dirt walkway located in the wooded area adjacent to the center during the past year. See MPD crime statistics below.

#### **Findings with Recommendations**

<u>Closed Circuit Television (CCTV)</u> There are no cameras on the exterior of the Community and Aquatic Center and along the dirt walkway, or within the wooded area.

• <u>Recommendation</u>: Cameras need to be placed on 14-foot poles, along the dirt walkway, and staggered within the wooded area, and placed on the lighting poles.

## Lighting

• <u>Recommendation</u>

Lighting should be added along the dirt walkway, and the wooded area. The area lacks sufficient lighting, and more lighting will provide additional safety for visitors. It is recommended that the light poles should be at a height of 14 feet, and be protected by tough polycarbonate. The lights should be LED, which gives extra illumination and promotes a sense of security.

Fencing The Community and Aquatic Center has no fencing around the adjacent wooded area.

• <u>Recommendation</u> Add fencing around the perimeter of wooded area. The fence should be a minimum of 8 feet in height.



Cameras should be staged along the dirt walkway, on top of lighting poles, or on the roofline of the center.

An 8-foot fence should be placed around the wooded area of the Tacoma Community Center and Aquatic Center. Additionally, lighting and cameras should be installed along the dirt walkway, and in the wooded area, and on the corners of the roofline of the center.

## **Summary Statement**

During the past year there has been a large increase in the number of robberies committed around the Tacoma Community and Aquatic Center and the adjacent Tacoma Recreational Center. It has been noted that there is a youth gang of approximately twenty that has been committing the robberies. The Threat Management Section of Protective Services Division, TMS/PSD/ DGS, has recommended additional lighting and cameras around both centers, as well as fencing around the dirt path and wooded area next to the Tacoma Community Center, where many of the robberies have taken place. The Metropolitan Police Department, MPD, has placed a temporary camera in front of the Tacoma Community and Aquatic Center, and stated more patrols will be checking the area.
