Requests for Information:

The selected Contractor will be required to work with DGS and the school staff to address swing timelines. With respect to Turner ES, the spaces adjacent to the area to be renovated will be occupied from 8:00 a.m. to 1:00 p.m., and the Contractor will be required to minimize noise and disruption to those programs to the greatest extent practicable.**
