### Issued: February 4, 2021

This Addendum No. 6 is issued on February 4, 2021. Except as modified hereby, the IFB remains unmodified.

Item #1: Section B.5 (of the IFB) is hereby revised as follows:

A Bidder responding to this IFB shall be deemed nonresponsive and shall be rejected if the Bidder fails to submit a subcontracting plan required by law. For contracts in excess of \$250,000.00, a Bidder shall ensure that its bid complies with the subcontracting requirement(s) in accordance with Section J.5 of this IFB.

The bids must also strictly comply with the SBE subcontracting plan criteria listed in D.C. Official Code § 2-218.46(d)(2) as follows:

(d)(1) Bids or proposals responding to a solicitation, including an open market solicitation, shall be deemed nonresponsive and shall be rejected if a subcontracting plan is required by law and the beneficiary fails to submit a plan that meets the criteria set forth in paragraph (2) of this subsection.

(2) A subcontracting plan shall include the following information:

- (A) The name and address of each subcontractor;
- (B) A current certification number of the small or certified business enterprise;
- (C) The scope of work to be performed by each subcontractor; and
- (D) The price to be paid by the beneficiary to each subcontractor.

(3) The subcontracting plan required by paragraph (2) of this subsection shall be provided before the District accepts the submission of the bid or proposal.
