1	Are we to provide Hosting only for 25 licenses of Prolog Manager/Prolog Converge or is DGS requesting a SaaS solution (licensing and hosting) for 25 licenses? If Hosting only, what is the mix of Prolog Manager and Prolog Converge licensing?	The Contractor is to provide 25 licenses of Prolog Manager/Prolog Converge/Mobile only.
2	This solicitation is for 12 months of hosting for a licensing subscription that expires on December 28th 2016. If there is a significant cost advantage for DGS to combine their licensing subscription and Hosting for 12 months, can an alternative licensing/Hosting option be offered by bidder?	No, DGS is not interested in any alternative licensing/Hosting Options.
3	Please define Project Team Programmers.	Project Team Programmers is a systems methodologies originally designed for undertaking governmental projects, such as the Structured Systems Analysis and Design Method (SSADM), assigned individual people to carry out individual tasks, and specified the role of analyst as being clearly separate from that of the programmers in the waterfall software development model. This methodology also clearly separated each of the individual "life-cycle" stages through which a system development project progressed.
4	Are we to provide hosting for the P6 and Document Locator applications as well?	The Vendor shall provide Hosting Services for P6 only.
5	What is the expected go-live date of the hosting?	The expected go-live date for Hosting Services is 14 business days after the award
6	What are the connectivity and compatibility issues" with or between what?	The connectivity and compatibility issues are between the vendors Hosting Agent and the Districts network
7	Does the bidder need to be an authorized provider of Trimble/Meridian Prolog support and services?	No
8	Does bidder need to be an authorized vendor of Trimble/Meridian Prolog?	No, the Bidder does not have to be an authorized vendor of Trimble/Meridian Prolog.
9	Is on-site PM Support a requirement?	No, on-site PM Support is not a requirement.
10	Is the \$250,000 value per contract year or combined value over the life of the contact?	The \$250,000.00 is the contract ceiling per year.
11	Please confirm that the LSDBE Certification Letter is only a submission requirement if bidder is eligible to take advantage of the Section C Economic Inclusion?	Only Bidders certified by DSLBD as a SBE/CBE have a certification letter, however all bidders must comply with subcontracting requirements in Section C.
12	The "Estimated Number of Hours" is to be based on what scope for Subject Matter Expert and Crystal Report Writers?	The hours should be 300 hours for each labor category.
