This Addendum No. 1 is issued by DGS on October 2, 2018. Except as modified herein, the Invitation for Bid (IFB) remains unmodified and is hereby published on the DGS website.

- ITEM NO. 1** **Pre-Bid Conference Sign In Sheet:** The sign-in sheet from the pre-bid conference held on September 28, 2018 is attached.

- ITEM NO. 2** **Section C of the IFB**
- Delete:** Delete Section C in its entirety
- Replace With:** Section C, renumbered from Section C.5 (Inventory Assessment) to Section C.6 (Inventory Assessment), and all other subsequent numbers were modified accordingly, all other information remains unchanged.
- ITEM NO. 3** **Section H.6.1.2**
- Delete:** **Delete Section H.6.1.2 in its entirety:** If there are insufficient SBEs to completely fulfill the requirement of paragraph H.9.1.1, then the subcontracting may be satisfied by subcontracting 35% of the dollar volume to any qualified certified business enterprises (CBEs); provided, however, that all reasonable efforts shall be made to ensure that SBEs are significant participants in the overall subcontracting work.
- Replace With:** If there are insufficient SBEs to completely fulfill the requirement of paragraph H.6.1.1, then the subcontracting may be satisfied by subcontracting 35% of the dollar volume to any qualified certified business enterprises (CBEs); provided, however, that all reasonable efforts shall be made to ensure that SBEs are significant participants in the overall subcontracting work.
- ITEM NO. 4** **Section H.6.1.3**
Delete Section H.6.1.3 in its entirety: A prime contractor that is certified by DSLBD as a small, local, or disadvantaged business

enterprise shall not be required to comply with the provisions of sections H.9.1.1 and H.9.1.2.

Delete: Delete Section H.6.1.3 in its entirety: A prime contractor that is certified by DSLBD as a small, local, or disadvantaged business enterprise shall not be required to comply with the provisions of sections H.9.1.1 and H.9.1.2.

Replace With: A prime contractor that is certified by DSLBD as a small, local, or disadvantaged business enterprise shall not be required to comply with the provisions of sections H.6.1.1 and H.6.1.2.

ITEM NO. 5 Section H.6.1.4

Delete: **Delete Section H.6.1.4 in its entirety:** Except as provided in H.9.1.5 and H.9.1.7, a prime contractor that is a CBE and has been granted a bid preference pursuant to D.C. Official Code § 2-218.43, or is selected through a set-aside program, shall perform at least 35% of the contracting effort with its own organization and resources and, if it subcontracts, 35% of the subcontracting effort shall be with CBEs. A CBE prime contractor that performs less than 35% of the contracting effort shall be subject to enforcement actions under D.C. Official Code § 2-218.63.

Replace With: Except as provided in H.6.1.5 and H.6.1.6, a prime contractor that is a CBE and has been granted a bid preference pursuant to D.C. Official Code § 2-218.43, or is selected through a set-aside program, shall perform at least 35% of the contracting effort with its own organization and resources and, if it subcontracts, 35% of the subcontracting effort shall be with CBEs. A CBE prime contractor that performs less than 35% of the contracting effort shall be subject to enforcement actions under D.C. Official Code § 2-218.63.

ITEM NO. 6 Section H.16.6 (xv.)

Delete: Delete Section H.16.6 (xv.) in its entirety

Replace With: Provide weight tickets via email within 24 hours of service.
