There is only a difference of 34,989 hours between both Asset Class groups. In comparison of Asset Class C and Asset Class E, there is a difference of 23,529 hours and a \$1 Million maximum difference (according to Addendum #8). The Percentage of 59% for Asset Class C is Armed SPO, while the percentage for Armed SPO's in Asset Class E is 49%. The maximum amounts should be reconsidered for both Asset Class Groups. Clarification: Potential Offerors are strongly encouraged to review Addendum No. 08 which provides updates to the cumulative estimated services hours for each Asset Class Group in both Attachments J.12 (Bid Forms) and Attachments J.13 (List of Locations). Further. Addendum No. 08, Item No. 8 updates the ID/IQ Minimum and

Each Asset Class Group includes varying numbers of locations with site specific service requirements including hours and Guard type assignments thus the non-guaranteed maximum ordering values are derived on this basis alone and the estimated hours and cost values are not comparative. Item No. 3: **Potential Offerors Request for Explanation** Can you please confirm that the Performance & *Add/Incorporate:* **Ouestion:** Payment Bonds required by the subject solicitation are due at the time of contract award for the base year only with renewal at the time of any exercise of option years under the contract. *Clarification:* Yes, the Performance and Payment Bonds are due at the time of Contract award and shall be for the Base Period value only. With the exercise of a subsequent Option Year a Performance and Payment Bond will be required for the value of the applicable period. Item No. 4: **Potential Offerors Request for Additional Explanation** The District will NOT accept nor entertain any additional requests for explanation, the question and answer period are hereby close with the issuance of Addendum No. 09.
