This Amendment No. 4 is being issued on February 06, 2015. Except as modified hereby, the Request for Proposal ("RFP") remains unmodified.

## Item #1 Request For Information:

- 1. We could not make it to the Pre-Proposal conference on January 22nd Is there any way we could schedule a site visit?
  - There will be no additional Site Visits.
- 2. Flooring What's the Square footage of the Dissipative Rubber Sheet Flooring?
  - The Dissipative Rubber Sheet Flooring is approximately 1,370 sf.
- 3. Flooring What's the existing flooring? Do we know what kind of sub-floor do we have?
  - Room 3176, has an epoxy coating applied to the concrete; the new rubber flooring can be directly applied.
  - Room 3183, the VCT shall to be removed and the concrete prepped for the rubber flooring.
  - All areas that receive the rubber flooring shall receive a rubber cove base.
- 4. Racks Please could we get information regarding the existing racks?
  - The Racks are Rittal 42U with PDU (Exhibit 4).
- 5. Is there an estimated project value? If not, do you have a rough estimate?
  - The estimated value is approximately \$150,000.00.
- 6. What is the Ceiling height / Type (push up, drywall, plaster, interlocking)
  - The Ceiling height is 9' 6" ft. and is an acoustical drop in ceiling.
- 7. What is the Distance to room 3199 and type walls / ceiling in between rooms 3176 & 3183.

- The Distance between the two rooms is approximately 48 feet, see A-7 Partial Floor Plan (Exhibit 1). See sheets A205W (Exhibit 2) and A901 (Exhibit 2) for partition Types.
- 8. Wire mold fill ratio at this time. In order to drop the "dual Cat6 network drops in the existing wire mold"
  - Wire mold is approximately 25% full.
- 9. We are seeking to clarify the terms of the bid bond required by the above-referenced solicitation. Usually, the minimum that we see on DGS solicitation is \$50,000. However, this is not specified in this particular solicitation, with only 5% of the bid amount specified on the Bid Bond Form. At the 5% level, the bid bond amount will be far less than \$50,000. Could the bid bond amount be clarified as soon as possible?
  - See Amendment #2.
- 10. Is there a bond requirements in the RFP?
  - See Amendment #2.
