2) Schematic Plan presented, PEDC gave overview of the latest updates to the drawings

- a) Further refining needed on the cafeteria / gym / kitchen / loading relationships
- b) <u>Lobby</u>
 - i) Wider, ceilings higher, about twice the size as the existing space, more open and inviting
- c) Food Prints garden
 - i) Returned to the SW corner of the site
 - ii) Considering retaining wall with a fence on top to outline the garden
 - iii) Current layout attempts to match the existing gardens square footage

d) Gathering Space

- i) At front plaza
- ii) "Meet and greet" area before and after school
- iii) Gracious steps around front plaza could also be seating for Gathering Space
- e) Cafeteria
 - i) Targeting 3 lunch periods / seating with generous after-hours seating capacity
 - ii) 238 loose seats in presentation mode, or 738 if operable wall is open
 - iii) Kitchen and servery relationship are still being refined
 - iv) Stage
- Platform with a few gracious steps wrapping around
- Stage could hold lunch tables to seat 1/2 the students at lunch
- f) Gym
 - i) The current budget precludes a full-size gym
- g) Media Center
 - i) Refining some of the connections between the program elements
 - ii) Looking at operable wall opportunities between computer lab and library
- h) Outdoor Classroom
 - i) Integrated to the specials area on the 2nd Floor
 - ii) Starting to incorporate some of the DCPS standards for shading, power, etc.
- i) Green Roof
 - i) At 3rd Floor (above Library)
 - ii) Windows will provide views out to green roof on 3rd and 4th Floors
 - iii) Will be accessible for maintenance only, not intended for Food Prints garden, the garden having been returned to the SW corner of the site
- i) Parking
 - i) Have 2 parking spaces over the required zone-dictated minimum
 - ii) The trailers at Watkins need to be removed from site; trailers need to be cleaned out first
- k) Pool

- i) DPR will be using a general Pool Maintenance budget to fix up the pool and the pool building
- ii) Aquatics personnel will be doing an assessment of the facility to see what it needs
- SIT has requested a timetable for the pool/pool-house assessment, list of current programs at Watkins and future programming opportunities
- Timing: Brent Sisco will check and provide feedback
 - iii) Dr. Lannette Woodruff lannette.woodruff@dc.gov is the DCPS POC for after-school programming; she is also interested in DPR programming, both current and future
 - iv) Community would like access to the pool-house restrooms from the field and without having to enter pool space (and after pool hours and after pool season)
 - i) SIT: some will be happy to hear pool is getting updated, and some will still be questioning about the lack of the a full-size gym
 - ii) SIT: Can the toilets be made accessible to the community using the fields?
- DPR: We will be studying that as part of the assessment.

3) Update on Geotechnical Investigation

- a) Drillers were on site last week
- b) Collecting samples for testing structural bearing strength and infiltration testing
- c) Will help team determine correct balance between green roof and underground systems

4) Update on the replacement windows

- a) Scheduled for delivery in mid-May 2015
- b) DGS will work with school administration to begin as much of the work as early as possible

5) <u>SIT Q&A</u>

- a) SIT: Canopy at entrance?
 - i) PEDC: Yes, we hope so. Depth will be a negotiation with zoning and DDOT
 - ii) Historic Preservation does not have to review or approve the design
- b) SIT: Likes the synergies of the outdoor classroom & surrounding uses
 - i) PEDC: There will be guardrails surrounding at perimeter
- c) PEDC We are looking at shifting the servery over to wrap behind the stage
 - i) SIT: should kids queue out in the hallway and enter servery on west end, or should they queue up along the east window side?
- d) SIT: How many kids can stand on the stage?
 - i) DCPS: Ed Spec sized stage is over 800 square feet, which is about the size of a classroom
 - ii) PEDC: The steps that wrap the stage also act as "risers" that you can line the kids up on for choir, etc.
- e) DCPS: Will there be curtains on the stage?
 - i) PEDC: Yes, there will be curtains
 - ii) Acoustical shells over stage will assist with pushing sound towards the back of the room
- Not guite to that level of detail yet
- PEDC has a really great acoustician on the team
- f) SIT: School has some vocal risers. Where could they be stored?
 - i) PEDC: there are two areas of Gym Storage near the Gym and Cafeteria
- g) SIT: The school would use the full gym + cafeteria combo space for:
 - i) Back-to-School night
 - ii) PTA meetings
- Usually try to rotate venue
- Currently always end up at Stuart Hobson ES because they have the space
- h) PEDC: Would like to schedule a meeting with the Watkins and DCPS Library personnel to work out more of the details
 - SIT: Please include a sink in the Media workroom
- i) SIT: Will there be natural light in the cafeteria?

- i) PEDC: Yes, through a combination of clerestory windows on the south edge and larger windows along the east side
